

1. **TulsipurSubmetropolitan City Office** invites electronic bids from eligible bidders for the construction of **Multipurpose Building Complex** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 160,000,000.00 without VAT.**
 - Minimum Work experience of similar size and nature: **One(1) double basement multistoried RCC framed structured building** Contracts within the last ten (10) years, each with a value of at least **NRs 179,000,000.00 without VAT.**
 - **The bidding capacity of the bidder should be equal to or more than NRs. 224,000,000.00.**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. E-Bidders may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egg. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

7. Electronic bids must be submitted to the office TulsipurSubmetropolitan City Office, Tulsipur-5, Dang through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12.00PM on 2078/08/16.** Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00PM on 2078/08/16** at the office of **TulsipurSubmetropolitan City Office, Tulsipur-5, Dang.** Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 6,500,000.00**, which shall be valid for 30 days beyond the validity period of the bid i.e. 150 days Or cash deposit in the Project's deposit account as specified below.
