The Tulsipur Sub-Metropolitan City, Office of the Municipal Executive, Tulsipur, Dang invites *electronic* bids from eligible and qualified bidders for the procurement of Goods **“Supply delivery and Installation of Backhoe Loader at Tulsipur Sub-Metropolitan City, Office of the Municipal Executive, Tulsipur, Dang”** under National Competitive Bidding (NCB) – the Single Stage, single Envelope Procedure Bidding procedures.
2. Under the Single Stage, single Envelope Procedure, Bidders are required to submit simultaneously two separate e-Bids, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 23 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Tulsipur Sub-Metropolitan City, Office of the Municipal Executive Tulsipur, Dang or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document **NRs. 3,000.00** in the following Rajaswa (revenue) account as specified below

5. Pre-bid meeting shall be held at **Tulsipur Sub-Metropolitan City, Office of the Municipal Executive at 1:00 on 01 February 2026.**
 6. Electronic bids must be submitted to the office Tulsipur Sub-Metropolitan City, Municipal Executive office Tulsipur, Dang through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 14 February 2026.**
 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12:15 P.M. on 14 February 2026 at the office of Tulsipur Sub-Metropolitan City, Office of the Municipal Executive, Tulsipur Dang.** Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of **NRs. 1,37,000**, which shall be valid for 30 days beyond the validity period of the bid (**i.e. 13 June 2026**)
 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
