1. **Tulsipur Submetropolitan City Office, Tulsipur-5, Dang** has allocated funds towards the cost of **Kha line, Gha line, link road and buspark parking area starunnati works** and intends to apply part of the funds to cover eligible payments under the Contract for **Kha line, Gha line, link road and buspark parking area starunnati works (TSMC/NCB/29/W/2082/083)**. Bidding is open to all eligible as per Section V of bidding document.
2. **Tulsipur Submetropolitan City Office, Tulsipur-5, Dang** invites electronic bids from eligible bidders for the construction of **Kha line, Gha line, link road and buspark parking area starunnati works ward no 5** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs.3,77,00,000.00**
- Minimum Work experience of similar size and nature: **asphalt concrete road and value of NRs.1,00,00,000.00**

3. Under the Single Stage, Two Envelope Procedure, Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Tulsipur Submetropolitan City Office, Tulsipur-5, Dang, contact no. 082-520233** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents may be purchased from the office **Tulsipur Submetropolitan City Office, Tulsipur-5, Dang**, by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of NRs. 5,000.00 till 5th feb, 2026 **during office hours**.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below.





8. The bids will be opened in the presence of Bidders' representatives who choose to attend at www.bolpatra.gov.np/egp on or before 14:00 hour on 5th Feb 2026 at the office of **Tulsipur-5, Dang**. Bids must be valid for a period of **90 days from the bid submission deadline** and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **7,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
